

Prevention Services Data Reporting Instructions

2023-2024

Legislation

[Ohio law](#) requires schools to report annually on the types of prevention-focused programs, services, and supports used to assist students in developing knowledge, skills, and awareness of consequences of risky behaviors. Prevention-focused programs, services, and supports help students develop knowledge and skills to engage in healthy behaviors and decision-making and increase students' awareness of the dangers and consequences of risky behaviors. Risky behaviors can include substance use, suicide, and bullying.

Reminders

- Provide responses for the 2023-2024 school year.
- Complete the report in one-sitting.
- Once submitted, responses cannot be edited.
- Each building can only submit one report.
- Review the list of curricula and programs and supports before selecting “other” to provide a write-in response.

Report Content

The prevention services data reporting process includes the following sections:

- School Information;
- Prevention-Focused Curriculum;
- Prevention-Focused Programs and Supports;
- Prevention-Focused Professional Development;
- Prevention-Focused Professional and Peer-Learning; and
- Prevention-Focused Community Partnerships, Family, and Student Engagement.

How to Begin

Ohio K-12 Help sent superintendents and principals an email that contains a link which provides access to complete Prevention Services Data Reports. If there are other staff who need access to the reporting dashboard, the superintendent should add the staff as a delegate. This will allow the other staff to access the IRN Session Dashboard as needed.

Once logged in to the IRN Session Dashboard, click “Create report” under the *Submit Report Status* heading (pictured below).

School Information

Curriculum

Prevention-focused curriculum is instruction provided in a planned sequence of culturally appropriate, science-driven strategies with specific learning expectations. The purpose of the curriculum is to facilitate attitude and behavior change.

If the school did not provide the prevention-focused curricula during the 2023-2024 school year, share barriers to implementation or move to the prevention-focused programs and supports section.

If the school provided prevention-focused curricula during the 2023-2024 school year, identify the prevention-focused curricula provided in this section. If the school provides a curriculum to students that is not listed on the reporting tool, select “Other” and provide the requested information about the curriculum. Add only curricula (not programs and supports) under this section. Select the types of funding used to provide curricula.

Programs and Supports

Prevention-focused programs and supports prevent risky behaviors and support mental health through information dissemination, social norming campaigns, mentoring groups, alternative programs, screening, referral, counseling and community-based processes.

If the school did not provide prevention-focused programs or supports during the 2023-2024 school year, share barriers to implementation or move to the professional development section.

If the school provided prevention-focused programs or supports during the 2023-2024 school year, identify the prevention-focused programs and supports provided in this section. If the school provides a program or support to students that is not listed on the reporting tool, select “Other” and provide the requested information about the program or support. Add only programs or supports (not curricula) under this section of the reporting tool. Select the types of funding used to provide the programs and supports.

- Mental Health Counseling is no longer listed as a prevention-focused program and support. Mental Health Counseling was removed from the list as it is outside of the scope of prevention. Additionally, school-wide frameworks like Positive Behavioral Interventions and Supports (PBIS) and Student Assistance Programs (SAP) were removed from the list. Please only include specific, prevention-focused programs and supports being provided to students in this section.

Professional Development

Prevention-focused professional development is the training of school personnel in topics related to wellness and safety. School personnel develop knowledge and skills necessary to support students and create a positive school climate upon receiving professional development.

If the school did not provide prevention-focused professional development for the 2023-2024 school year, move to the peer learning section. If the school provided prevention-focused professional development for the 2023-2024 school year, identify the professional development topics in this section. If the list does not include the professional development topic that the school provided to staff, select “Other” and provide the requested information about the professional development topic.

- Please only include the topic areas the professional development covers. Do not include the name of the presenter or the vendor providing the professional development.

Select the types of staff that receive professional development in each of the topic areas identified.

Professional and Peer Learning

Prevention-focused professional and peer learning are opportunities that allow schools to engage and communicate with other schools or professionals with expertise in prevention education.

If the school did not provide activities or methods to engage in prevention-focused professional and peer learning in the 2023-2024 school year, move to the community partnerships, family and student engagement section.

If the school provided activities or methods to engage in prevention-focused professional and peer learning identify the activities or methods used in this section. If a prevention-focused professional and peer learning activity or method was implemented is not listed on the reporting tool, select “Other” and provide the requested information about the professional and peer learning activity or method.

Community Partnerships, Family, and Student Engagement

Community Partnerships

If the school did not partner with external partners to provide prevention-focused services to families during the 2023-2024 school year, move to the question about types of family engagement.

If the school partnered with external partners to provide prevention-focused services to families, identify the external partners. If the list does not include the partnering agency, select “Other.”

Family Engagement

If the school did not provide prevention-focused engagement with parents and families during the 2023-2024 school year, move to the student engagement section.

If the school provided prevention-focused engagement with parents and families during the 2023-2024 school year, identify the types of engagement utilized in this section. If the list does not include the type of engagement the school utilized, select "Other."

Student Engagement

If the school did not provide prevention-focused engagement to students during the 2023-2024 school year, move to the sharing your story section.

If the school provided prevention-focused engagement to students during the 2023-2024 school year, identify the level of engagement opportunities offered to students in this section.

Sharing Your Story

Optionally, share a story about how best practices in evidence-based prevention have positively impacted the school. Click "Next" to move to the final page of the reporting tool.

Confirm and Submit

Enter your name, role or title, email address, and phone number, and submit the report. The screen will show a confirmation when it is submitted. Click the hyperlink to download a PDF copy of the submitted responses for your records.
